## INSTRUCTIONS

- (1) No application shall be entertained unless it is properly filled in and submitted along with necessary documents in conformity with the Regulations and Instructions of the University.
- (2) No candidate shall be allowed to offer any subject other than those mentioned in this application, provided the candidate is eligible under the Regulations to offer such subject.
- (3) No application for admission to the examination shall be entertained after the due date. In exceptional cases permission may be granted, provided the reasons for the delay were considered to be sufficient and the application alongwith the requisite fees reached the Controller of Examinations within seven days after the due date with a late fine of Rs.20/-.
- (4) The Heads of Institutions shall forward fees in Cheques, Remittance Transfer Receipts or Bank Drafts made payable to the Comptroller of Finance, Utkal University, or credit the same in the State Bank of India in the Utkal University General Fund Account. The date of issue in case of cheques and the date of deposit in case of Remittance Transfer Receipts and Bank Drafts shall be taken to be the date of payment of fees to the University.

In case of fees deposited by the Heads of Institutions or individual private candidates in the State Bank of India, the date of deposit in the above Bank shall be taken to be the date of payment of fees to the University. No fee shall be accepted by the University in CASH.
