ORDER

WHEREAS, NabaKrishnaChoudhury College of Teacher Education, Angul, Street No. Hakimpur, Vill-Angul, PO-Angul, Town/City-Angul, Dist-Angul, Odisha-759122 (B.Ed.) (OR-S/E-796 & APE00754 & ERCAPP1857) was granted recognition for B.Ed. course from time to time with an intake of 100 vide ERC order No. ERC/7-84.6(11).16/2008/10482 dated 14.03.2008 and ERC/7-160/11/12 & NCTE B.Ed. - Addl. Intake/2014/24230 dated 24.02.2014 granted permission for additional intake of 100, thus making the total intake of 200. Revised recognition order from the academic session 2015-2016 with an intake of 200 (four basic units) vide dated 31.05.2015 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 254th meeting held on 16th - 17th April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

3. AND WHEREAS, the ERC in its 271st Meeting held on 24th - 25th April, 2019 considered the matter and final show cause notice u/s 17(1) was issued on 18.05.2019 on the following grounds:-

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

4. AND WHEREAS, the institution has submitted reply dt.07.06.2019 in response to show cause notice received on 12.06.2019. The ERC in its 278th meeting held on 16th - 18th January, 2020 after considering the matter and observed that the institution is still deficient on the following grounds:-

- List of teaching faculty is not duly approved by the affiliating body.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021.
