ORDER

WHEREAS, College of Teacher Education, Balasore, Odisha-756001 (OR-S/E-1/1996) was granted recognition for B.Ed. course with an intake of 100 vide ERC orderNo. ERC/7-19/2001/1802 dated 28.06.2001, followed by revised recognition order from the academic session 2015-2016 with an intake of 100 (two basic units) vide dated 31.05.2015 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 254th meeting held on 16th – 17th April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:

- f. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
g. Approved building plan by the concerned competent Govt. Engineer/Authority.
h. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
i. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
j. Confirmation on website updates of the institutions with all details along with affidavit.

3. AND WHEREAS, the institution has submitted reply dt.29.05.2019 in response to show cause notice issued by ERC letter dated 20.04.2018. The ERC in its 275th Meeting held on 26th – 27th July, 2019 considered the matter and final show cause notice u/s 17(1) was issued on 18.06.2019 on the following grounds:-

- (iii) Faculty list is not as per NCTE Regulations, 2014. Faculty comprises 1+3 as against the requirement of 1+15 for running 100 intake of B.Ed. Course.
(iv) Guest faculties are not accepted.
(v) Building plan is not submitted.

4. AND WHEREAS, the institution has submitted reply dt. 16.09.2019 in response to show cause notice issued by ERC letter dated 18.06.2019. The ERC in its 278th meeting held on 16th – 18th January, 2020 after considering the matter and observed that the institution is still deficient on the following grounds:-

- (i) 04 Guest faculties appointed is not permitted as per NCTE Regulation, 2014.
(ii) Faculty list uploaded on the institutional website who are not qualified as per NCTE Regulation, 2014.
(iii) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.




