ORDER

WHERES, in exercise of the powers conferred by sub-section(2) of section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulatios, 2009 the National Council for Teacher Education has notified the Regulation, 2014 on 1.12.2014.

- 2. **AND WHEREAS,** the institution viz. **Hindi Teachers' Training Institute, Block-29, Old Secretariate, Dist- Cuttack, Orissa-753001** was granted recognition for conduct of B.H.Ed. Course of **One year** duration with an annual intake of 100 vide ERC order no. **ERC/7-78.6(I). 7/2007/69201** dated **06.08.2007.**
- 3. **AND WHEREAS,** the institute viz. Hindi Teachers' Training Institute,Block-29, Old Secretariate, Dist- Cuttack, Orissa-753001 has by affidavit dated 31.03.2015 consented to come under New Regulations 2014 and sought for **Two Basic Units in B.H.Ed. course,** which require additional facilities.
- 4. **AND WHEREAS,** it has been decided to permit the institution to have two basic units of 50 students each with subject to fulfill following conditions namely.
- (i) The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and informa Regional Committee with required documents by October 31st 2015.
- (ii) The applicant-institution for additional unit will be required to submit the required documents such as land documents. Encumbrance Certificate (EC). Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available otherwise it can also be given to the Visiting Team at the time of inspection.

- (iii) the regional Committees shall arange for verification of documents inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- 5. **Now therefore,** in the light of the aabove and in terms of section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014 the Eastern Regional Committee, NCTE hereby grants recognition to **Hindi Teachers' Training Institute**, **Block-29**, **Old Secretariate**, **Dist- Cuttack**, **Orissa-753001**for conducting B.H.Ed Programme of **two years** duration for with an annual intake of **100** for **two basic units of 50 students each** from the academic session **2015-2016** subject to fulfillment of the conditions mentioned herein beforte 31.10.2015.
- 6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.
- 7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
 - a) Sanctioned programmes along with annual intake in the institution.
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c) Name of faculty members who left or joined during the last quarter.
 - d) Names of students admitted during the current examination and in the entrance test, if any , date of addmission, etc.
 - e) Fee charged from students.
 - f) Available infrastrutural facilities.
 - g) Facilities added during the last quarter
 - h) Number of books in the library, journals subscribed to and additions, if any , in the last quarter.
 - i) The affidavit with enclosure submitted along with application.
 - j) The institution shall be free to post additional relevant information. If it so desires.
 - k) Any false or incomplete information on web-site shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions of the provision of the NCTE Act. Rules, Regulations and Order made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17 (1) of the NCTE Act.
