**ORDER**

WHEREAS, Nalini Devi Womens' College of Teacher Education, Unit-III, Kharvela Nagar, Bhubaneswar, Odisha-769010 (OR-S/E-8/96 & APE00555) was granted recognition for B.Ed. course with an intake of 200 vide orders dated 31.05.1994, 16.10.1996 and 20.06.2008 respectively, followed by revised order vide No.32767 dated 31.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 254<sup>th</sup> Meeting held on 16<sup>th</sup> - 17<sup>th</sup> April, 2018 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution.

3. AND WHEREAS, the ERC in its 272<sup>nd</sup> Meeting held on 30<sup>th</sup> - 31<sup>st</sup> May & 1<sup>st</sup> June, 2019 considered the matter along with the reply dated 07.05.2018 & 27.05.2019 submitted by the institution in response to SCN and Final Show Cause Notice u/s 17(1) was issued on 18.06.2019 to the institution on the following grounds:-

- (i) The submitted faculty comprises of 1+8 instead of 1+15 required under NCTE Regulations, 2014. Two faculties appointed on contractual basis are not accepted.
- (ii) Website not maintained and updated.

4. AND WHEREAS, the ERC in its 275<sup>th</sup> Meeting held on 27<sup>th</sup> July, 2019 considered the matter along with the letter dated 27.06.2019 from the institution in response to final show cause notice and observed as under:-

- (i) The submitted faculty comprises of 1+8 instead of 1+15 required under NCTE Regulations, 2014. Two faculties appointed on contractual basis are not accepted.
- (ii) Website not maintained and updated.

Reply vide letter dated 27.06.2019 from the institution seeking extension of time to comply the deficiencies is not accepted by the Committee.

**In view of the above, the Committee decided as under:**

Recognition granted to B.Ed. course is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session **2020-2021**.
