- 3. The bidders must clearly mention the price (item wise) inclusive of GST in the financial bid (Annexure-II).
- 4. **OPENING OF BIDs**: The Technical Bids will be opened on **17.01.2026 at 11:00 A.M** followed by opening of Financial Bids in presence of the Tender Committee of RNIASE, bidders or representative of the bidders. No separate intimation will be given to the bidders in this regard.
- 5. The Committee reserves the right to cancel any part or the entire tender without assigning any reason thereof.
- 6. Award of Contract: Financial bids with lowest price quotation for the assignment as per Annexure-II will be considered for negotiations and award of contract. The supply, installation and commissioning of items must be completed strictly within 10 days from the date of issue of supply order.

- 8. In the financial bid the **total figures** should be **written in figures** followed by **words**.
- 9. Each page of the tender document should be signed by the bidder with seal, in token of having understood and accepted the terms and conditions of the contract and serially numbered and page marked.
- 10. A bid submitted cannot be withdrawn. The bidder or his authorized representative (one person only) will be allowed to be present at the time of opening of tenders.
