## **ORDER**

WHEREAS, the Eastern Regional Committee, NCTE had initially allowed the institution viz. College of Teacher Education, Balangir, Odisha–767001 to continue B.Ed. course vide letter dated 31.05.1996, subsequently the institution was granted recognition time to time vide orders dated 17.10.1996, 22.06.1998, 18.02.1999, 02.09.1999, 06.04.2000, 05.02.2001 and 21.06.2005 for conducting B.Ed. course with approved intake mentioned therein.

- 2. **AND WHEREAS**, on implementation of NCTE's Regulation, 2014, Revised Recognition Order (RRO) was issued for conducting B.Ed. course of two years duration with an intake of 100 (two basic units) from the academic session 2015-2016 vide No. F.ERC/NCTE/OR-S/E-6/96 & APE00346/B.Ed.(Revised Order)/2015/32760 dated 31.05.2015 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. **AND WHEREAS**, the ERC in its  $278^{th}$  meeting held on  $16^{th} 18^{th}$  January, 2020 considered the matter and accordingly, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 vide order No.62160 dated 28.01.2020 from the academic session 2020-2021 on the below mentioned grounds:
  - i. List of teaching faculty duly approved by the affiliating body has not submitted.
  - ii. The institution has not submitted proper Building Plan (BP) mentioning the plot No., total land area and total built up area.
  - iii. Extension of time for construction of building is not permitted as per Regulation.
  - iv. Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.
- 4. **AND WHEREAS**, the institution preferred an appeal at NCTE Hqrs. against the ERC's withdrawal order dated 28.01.2020. The Appellate Authority vide its Order No.89-219/E-193007/2021 Appeal/19<sup>th</sup> Meeting, 2021/101328 dated 19.08.2021 decided to set aside the impugned order dated 28.01.2020, therefore, the institution is entitled to the benefits of recognition proportionate to the number of faculty as per NCTE Regulations, 2014 until a fresh withdrawal order is passed by the Regional Committee. The case of the institution is remanded back to ERC for revisiting the matter after the appellant institution submits the list of faculty approved by affiliating University and a Building Completion Certificate.

AND WHEREAS, the Hon'ble High Court of Delhi vide order dt.30.07.2021, passed in W.P (C) 260/2021 titled as Arihant College vs NCTE held as follows:

"The institution is, therefore, entitled to the benefits of recognition until a fresh withdrawal order is passed. The order of restoration of recognition should be issued within two weeks of the order of remand being communicated to the regional committee, or upon request of the concerned institution. This streamlined procedure would obviate the multiplicity of litigation which is being witnessed at present. Neither the concerned institutions nor the NCTE should be put to the burden of filing or defending proceedings before the Court for this purpose."

"Restoration of recognition order for B.Ed. course with an annual intake of 50 (one basic unit) be issued".

NOW THEREFORE, recognition withdrawn vide order No.62160 dated 28.01.2020 to the institution viz. College of Teacher Education, Balangir, Odisha-767001 for B.Ed. course is hereby restored with an annual intake of 50 (one basic unit).
